

NOTES ON CONTRIBUTORS

SANTIAGO SIA, Ph.D., D.Litt. (University of Dublin), prior to retirement, was Professor and Dean of Philosophy, Milltown Institute of Theology and Philosophy, Dublin, Ireland, and previously Professor of Philosophy and Director of Ethical Studies, Loyola Marymount University, Los Angeles, USA. After philosophical studies in the Philippines, he obtained a Ph.D. in Philosophy from Trinity College, University of Dublin. The National University of Ireland awarded him the D.Litt, its highest academic award, for his scholarly publications in philosophy of religion, metaphysics, ethics, education, and interdisciplinary studies. He is the recipient of various awards, including the Robert Taylor, SJ, Chair in Philosophy at LMU, and Senior Research Fellowship from the Katholieke Universiteit Leuven, Belgium. He was a consultant on ethical matters and on education for the U.N. International Atomic Energy Agency in Vienna, Austria, and as an expert adviser for the European Commission, Directorate H-Nuclear, Belgium, and for Autorité de Sûreté Nucléaire, Palais des Congrès, France.

BRENDAN SWEETMAN, Ph.D. (University of Southern California) is a professor of philosophy and holds the Sullivan Chair in Philosophy at Rockhurst University, Kansas City, Missouri, USA. He is the author or editor of sixteen books, including *The Crisis of Democratic Pluralism: The Loss of Confidence in Reason and the Clash of Worldviews* (Palgrave MacMillan, 2021), *Religion and Science: An Introduction* (Continuum, 2010), *The Vision of Gabriel Marcel* (Rodopi, 2008), *Religion: Key Concepts in Philosophy* (Continuum, 2007), *Why Politics Needs Religion: The Place of Religious Arguments in the Public Square* (InterVarsity, 2006), *A Gabriel Marcel Reader* (St. Augustine's Press, 2011). He has published more than one hundred articles and critical reviews in a variety of journals, collections, and reference works, including *International Philosophical Quarterly*, *American Catholic Philosophical Quarterly*, *Philosophical Quarterly*, *Review of Metaphysics*, *The Stanford Encyclopedia of Philosophy*, *Encyclopedia Britannica*, and *New Catholic Encyclopedia*. He is an elected Fellow of the International Society for Science and Religion. He is the current President of the Gabriel Marcel Society, and Vice-President for North America of the World Conference of Catholic University Institutions of Philosophy (COMIUCAP).

HUSEIN INUSAH, Ph.D. (University of Ghana) is a Senior Lecturer and the Head of the Department of Classics and Philosophy at the University of Cape Coast, Cape Coast, Ghana. He obtained his Ph.D. through a split-site Ph.D. program made possible by a collaboration between the University of Ghana, Ghana, and the University of Rochester, NY, USA. Dr. Inusah has been teaching at the University of Cape Coast as a regular faculty since October 2013. He is also an adjunct faculty at the Department of Philosophy and Classics, University of Ghana, Accra, Ghana, where he handles both undergraduate and graduate courses in philosophy.

ABDUSSALAM ALHAJI ADAM, Ph.D. (Olabisi Onabanjo University) is a Senior Lecturer and Head of the Islamic Section in the Department of Religion and Human Values at the University of Cape Coast. He received his early education in the traditional madrasa institution before formal education and was a graduate of the University of Cape Coast. He holds three master's degrees and a doctorate from Olabisi Onabanjo University in Nigeria. He is currently a Senior Lecturer and Chief Examiner in Islamic Studies at the West African Exams Council in Accra, Ghana. His area of research is conflict and conflict resolution.

MARÍA JOSÉ GÓMEZ, MPhil, MLitt. (University of Cambridge; University of Oxford) is a Full-Time Professor in Humanities at the Universidad Panamericana in Mexico. She is currently a Ph.D. candidate at the University of Oxford. Her research interests mainly lie in contemporary Political Philosophy, particularly Democratic Theory and Feminism. Additionally, she has side interests in the history of Political Philosophy and the Didactics of the Humanities. Her works include book chapters on the Capabilities Approach (2012) and Person-Centered Feminism (2023), as well as forthcoming articles on curriculum development in the Humanities and legal exclusions to the Right to Candidacy.

IAN RAYMOND B. PACQUING, Ph.D. (University of Santo Tomas), is an Associate Professor of Philosophy at the University of Santo Tomas, Manila. He is also a research fellow at UST Research Center for Culture, Arts, and the Humanities. His research focuses on social philosophy, critical theory, and the psycho-social philosophy of Erich Fromm. He has already published several articles on Fromm's psycho-social philosophy, humanism, and psychoanalysis; the most recent one is on existential relationships. He teaches Ethics, Modernity, and St. Thomas and Critical Thinking at the undergraduate and postgraduate levels.

FEORILLO A. DEMETERIO III, Ph.D. (University of the Philippines) is a Professor of the Department of Filipino, College of Liberal Arts, and the Director of the University Research Coordination Office, De La Salle University. He is the author of the books *Ang mga Ideolohiyang Politikal ng Catholic Bishops' Conference of the Philippines* (2012), *Ferdinand Blumentritt and the Philippines* (2013), and *The Socio-Political Discourses of the Catholic Bishops' Conference of the Philippines* (2018), as well as of various essays on hermeneutics, cultural studies, Philippines studies, and Filipino philosophy. He was a visiting research professor at the Council for Research in Values and Philosophy, Catholic University of America, in 2013 and at the Divinity School of Chung Chi College, Chinese University of Hong Kong, in 2021. He is a co-founder of the Andrew Gonzalez Philippine Citation Index.

IDDO DICKMAN, Ph.D. (Bar-Ilan University), is an Associate Professor of Philosophy at Nanjing University (China). He previously taught and conducted research at the University of Colorado Boulder, Penn State University, Cambridge University, The Catholic University of Louvain, and Vilnius University. He specializes in post-structuralist philosophy (Deleuze, Derrida, Blanchot), aesthetics,

and Jewish philosophy (especially Talmudic). His work focuses on paradoxes of self-reference from a continental philosophy point of view. He is the author of the monograph *The Little Crystalline Seed: The Ontological Significance of the Mise en Abyme in the post-Heideggerian Thought* (SUNY Press, 2019).

ROLAND THEUAS DS. PADA, Ph.D. (University of Santo Tomas) is an Associate Professor of the Department of Philosophy, Faculty of Arts and Letters, University of Santo Tomas. Under the same university, he is also a researcher from the Research Center for Culture, Arts and Humanities. He is an Editor-in-Chief of the journal *Kritike: An Online Journal of Philosophy*. He has published articles in local and international journals. Cambridge Scholars Publishing published his book *Axel Honneth's Social Philosophy of Recognition: Freedom, Normativity, and Identity* in 2018. His research interests are in Post Structuralism, Phenomenology, Critical Theory, Recognition Theory, and Filipino Philosophy.

PATRICK ANDRE C. MENCIAS, M.A. (University of Santo Tomas) is currently an Instructor at the Department of Language and Literature, Far Eastern University, Manila, Philippines. He is a graduate of A.B. Philosophy from the University of Santo Tomas (2019), and his M.A. in Philosophy *Cum Laude* (2022) from the Graduate School of the same university. His research interests include Phenomenology, Emmanuel Levinas, and Florentino Hornedo.
