SUNGJIN PARK, Ph.D. (Sungkyunkwan University) is a Professor in the Department of Ethics Education at Gwangju National University of Education (South Korea). His research focuses on political philosophy under conditions of emerging technologies and global crises, with particular attention to democracy and political agency in the era of artificial intelligence, climate change, and social despair, developed through the concept of “post-demos.” He holds an M.A. in Western Philosophy and a B.A. in Philosophy and Korean Language and Literature from Inha University, and his doctoral work examined nineteenth-century British liberalism. His recent publications include “The Work of Art in the Age of Generative AI: Aura, Liberation, and Democratization” (AI & Society, 2024) and “Theodor W. Adorno, Artificial Intelligence, and Democracy in the Postdigital Era” (Postdigital Science and Education, 2023). He is also the translator of Political Theory of the Digital Age (Greenbee, 2024).

AGUSTIN MARTIN B. RODRIGUEZ, Ph.D. (Ateneo de Manila University) is a professor of Philosophy (ret.) at the Ateneo de Manila University. He is the author of *Governing the Other* (2009), *May Laro Ang Diskurso ng Katarungan* (2014), and *The Stories We Tell When We Tell Stories About Ourselves* (2025). Two other books, *Kung Bakit May Mga Tanong ang Buhay* (2024) and *Mula Bayang Sawi Tungo sa Lupang Hinirang* (2024), are both shortlisted for the 43rd National Book Award for Philosophy. His book *Repentance and Rebirth at the End of Life as We Know It* (2021) was awarded the National Book Award for Philosophy. He has also written articles on poverty, good governance, and just and sustainable development. He is currently exploring the Filipino conceptions of the good life and the just society through literature and film.

JOVE JIM AGUAS, Ph.D. (University of Santo Tomas, Philippines) is a Professor of Philosophy at the University of Santo Tomas. He is also a research faculty at the Center for Theology, Religious Studies, and Ethics of UST. He is the Executive Governor of the Philippine National Philosophical Research Society and the Editor-in-Chief of this journal. His publications include *Person, Action and Love: The Philosophical Thoughts of Karol Wojtyła* (2014) and *The Good and Happy Life: An Introduction to Ethical Systems* (2019). He received the Dangal ng UST Hall of Fame Award in 2016. He delivered the Annual Karol Wojtyła Lectures in 2023 at the John Paul II Catholic University of Lublin, Poland.

YANG JIN, Ph.D. (Philippine Women's University, Philippines) is a professor of Music Philosophy at Huzhou University in Huzhou. She received her degree from the School of Music at the Women's University of the Philippines in July 2023 and holds certification as a senior psychological counselor from the Personnel Network of the Chinese Ministry of Social Security. She has published several academic papers and is the author of *Exploration and Research on the Diversity of Ethnic Music in Southern China*. She has led and completed national, provincial, and ministerial research and education projects.
